

**HYUNDAI BRISBANE LIONS MEMBERS' LOYALTY OFFER
TERMS AND CONDITIONS**

1. Any information on how to participate in this promotion forms part of these Terms and Conditions. Participation in the promotion is deemed acceptance of these terms and conditions.
2. Participation is open to all Brisbane Lions Football Members (Members) (excluding 3-Game Membership). However, employees and their immediate families of Hyundai Motor Company Australia Pty Ltd, Brisbane Lions Football Club Ltd and their associated agencies and companies and Conergy Pty Limited are not eligible to enter. Fleet owners, government authorities and agencies or persons acquiring vehicles for business or commercial purposes are also excluded from participating in the promotion.
3. This promotion is limited to member purchases of Hyundai vehicles before **31/12/2011** and all claims must be received before 30/06/2012. The promotion and the benefits of the promotion may not be combined with any other similar promotion run by Hyundai. Any claim for the loyalty bonus under this promotion will make the claimant ineligible to claim under any similar promotion or loyalty bonus scheme which Hyundai may be running for other sports clubs or associations.
4. Subject to these terms and conditions, after purchasing a Hyundai vehicle, the member will be able to select one of the following loyalty bonuses:
 - Cash Bonus as set out in clause 5 and 6(a) below; or

- a. The member can purchase any of the above new Hyundai vehicles (Vehicle) from any available Hyundai dealer at any price.
 - b. Second hand or demonstration vehicles are excluded from this promotion.
 - c. Members will not be required to identify themselves as a member of the Brisbane Lions Football Club at the time of purchase of the vehicle.

6. (a) How to claim the Cash Bonus.

- a. Following purchase and registration of the vehicle, the member can download the Member Loyalty Bonus Claim Form (Claim Form) available on the website <http://www.hyundai.com.au/About-Hyundai/Community/Sponsorships/Sponsors/Brisbane-Lions/default.aspx>
- b. To claim the Cash Bonus, the member must post, email or fax the completed and signed claim form to Hyundai at the address set out on the Claim Form, together with:
 - i) A copy of the Brisbane Lions Football Club Membership card;
 - ii) A copy of the registration papers of the vehicle; and
 - iii) A copy of the sales contract.
- c. The name of the member must match the name contained in the sales contract and the registration papers.
- d. Hyundai will not be responsible for any claim forms that are lost in the mail, during transmission or are received illegible or damaged by Hyundai.
- e. The claim form must be received by Hyundai within 6 months from the date of purchase of the vehicle. Hyundai will not accept any claim forms received later than **30/06/2012**
- f. The member is only entitled to the Cash Bonus if the person was a member at the time of purchase and delivery of the vehicle. Upon receipt of the claim form, Hyundai will verify the identity of the member and the valid membership at the time of purchase and delivery of the vehicle.

- b. To claim the Conergy 1.5kW Solar Power System Bonus (Conergy Bonus), the member must post, email or fax the completed and signed claim form to Hyundai at the address set out on the Claim Form, together with:

- (i) A copy of the Brisbane Lions Football Club Membership card;
 - (ii) A copy of the registration papers of the vehicle; and
 - (iii) A copy of the sales contract.
- c. The name of the member must match the name contained in the sales contract and the registration papers.
- d. Hyundai will not be responsible for any claim forms that are lost in the mail, during transmission or are received illegible or damaged by Hyundai
- e. The claim form must be received by Hyundai within 1 month from the date of purchase of the vehicle. Hyundai will not accept any claim forms received later than **31/01/2012**.
- f. The member is only entitled to the Conergy Bonus if the person was a member at the time of purchase and delivery of the vehicle. Upon receipt of the claim form, Hyundai will verify the identity of the member and the valid membership at the time of purchase and delivery of the vehicle.
- g. Upon verification of identity and valid membership of the member, Hyundai will raise a purchase order to Conergy Pty Ltd to supply and fit 1.5 kW solar power systems.
- h. The Conergy 1.5kW Solar Power System Bonus will be supplied by Conergy Pty Ltd and therefore, if the member selects the Conergy Bonus, the member must accept Conergy Pty Ltd's terms and conditions found at the following website: **www.conergy.com.au**. The member should note that additional charges may be incurred by the member depending on the location and specifications of the installation and the offer is based on the renewable Energy Certificates trading at a rate of \$40 per certificate, should the value of the certificates fall below this value in the open market then Conergy Pty Ltd or its appointed installation agent will advise the member of additional costs that may be incurred. - i. Installation for the promotion is base don metropolitan city locations only, should installation be other location additional costs may be incurred. Conergy and or Conergy authorized representative shall advise at time of booking site inspection.
- j. Conergy Pty Ltd will arrange a site inspection of your home and also arrange to complete the paperwork for the Renewable Energy Certificates (solar Credits).
- k. The member agrees that all rebates will be assigned to Conergy Pty Ltd. Should the Homeowner not be eligible for solar credits then this offer is not available and the homeowner would need to resort to Cash Bonus as above.
- l. If, for any reason after submitting a Claim Form for the Conergy Bonus, the member decides not to proceed with the Conergy Bonus, the member may, upon notification to Hyundai, seek to claim the Cash Bonus as set out above in substitution for the Conergy Bonus. - n. Hyundai reserves its rights to refuse or reclaim the Conergy Bonus if, at the time of processing or subsequently, Hyundai discovers that the Membership at the time of purchase and delivery of the vehicle by the member was not valid or legitimate.
